Bidders are cautioned that subsequent responses or contract addenda may affect or vary a response previously given and any such subsequent response or addenda should be taken into consideration when submitting a bid for the project. Inquiries must be submitted by the deadline specified in the project Special Provisions.

3	Is there a PLA for this project?	Please refer to section 3-1.09 for information on the County's Project Stabilization/Community Benefits (PSCBA) Agreement. This project is over \$1 million and is a "Covered Project" as defined in the agreement.
4	Will there be night work? What are the working hours for this project?	Please refer to Section 12-4.01A(5) of the project specs.
5	Is there a target date for starting this project?	We anticipate issuing a Notice to Proceed sometime in June 2024.
6	Are there any DBE goals?	This project does not have DBE goals.

10	Is the C&G intended to be placed monolithically with the bioretention wall?	No. See Details 1 and 3 on Sheet 19. The wall is monolithic and extends below curb as stated in Note 1.
11	Is the C&G at the bioretention wall to have a key-way?	See Details 1 and 3 and Note 3 on Sheet 19.
