# General Project Description


## Project Locations

- Twenty two (22) locations in Castro Valley, San Lorenzo, unincorporated area of Hayward and San Leandro in Eden Township.

## Scope of Work

- Provide and implement traffic control plan and construction area signs. Notify and coordinate with property owners
- Saw cut and remove damaged sections of concrete curbs, gutters, and sidewalks
- Reconstruct damaged portions of concrete curbs, gutters, driveways, driveways and walkway conforms, pedestrian ramps, median island paving and curbs
- Replace a minimum of twelve (12)-inch wide section of asphalt concrete pavement adjacent to gutter
- Remove existing roots, install root barriers and restore any disturbed lawn and planting areas to their original condition or better
- Miscellaneous works, including removal of concrete forms, disposal off-site of all unsuitable materials, and cleanup of site.

# Contract and Labor Compliance

- **Labor Code Requirements**

- Prevailing wage is applicable to all PWA projects
- Elation Systems is the web-based system that contractors and subcontractors are required to use on a weekly basis for the submission of certified payroll.

- **Contract Compliance**

- Elation Systems is also utilized to monitor subcontractor utilization. Contractors are required to upload all payments made to their subs.
- DIR: All bidders (prime and subcontractors) who bid on a public works project must be registered with the Department of Industrial Relations by the date of bid opening. \$300 ANNUAL FEE.
- Alameda County Public Works Agency strongly encourages the participation of disadvantaged/minority/women-owned business enterprises in all District capital improvement construction projects.
