**GENERAL WORK DESCRIPTION:** The project consists of providing and implementing a traffic control plan; providing construction area signs; providing and implementing water pollution control plan; providing construction site management; sweeping streets; notifying and coordinating with utility companies, schools, businesses, and property owners; clearing and grubbing; construction survey staking; replacing (existing) guardrails and installing new alternative in-line terminal systems; furnishing and applying water; cleaning site; and, other related work necessary to complete said project. The project and its construction activities include Best Management Practices to protect the environment;

**ALLOTTED TIME FOR COMPLETION:**

- 45 working days

**LICENSE REQUIREMENT:** The Contractor must have a Class A or C-13 license at the time of bid opening. Licensing must be maintained throughout the Contract duration.

**REGISTRATION REQUIREMENT:** To be qualified to bid or to be listed in a bid proposal, all contractors must be registered with the Department of Industrial Relations.

**BIDS DUE:** February 27, 2024 at 2:00 p.m., at the Public Works Agency, 951 Turner Ct, Rm 300, Hayward, CA 94545. Bids submitted after this deadline will be rejected. Submissions accepted prior will be publicly open and read immediately following the deadline. Include a bidder's security equal to at least 10 percent of the bid. **PREBID MEETING:** There is a **mandatory pre-bid meeting** required for all prime contractors. Interested sub-contractors are invited and encouraged to attend the pre-bid meeting.
