## CONTROL OF WORK

Upon request, immediately remove and do not again use a subcontractor who fails to satisfactorily prosecute the work.

Before starting work, assign a representative to:

1. Receive the Engineer's orders
2. Prosecute the Engineer's orders
3. Supervise the workers
4. Coordinate the subcontractors' work

The representative must be present at the job site while work is in progress. Submit the representative's name and telephone number so the representative can be easily contacted to perform emergency work while work is not in progress.

### 5-1.17 CHARACTER OF WORKERS

If a worker appears to the Engineer to be incompetent or acts disorderly or improperly, discharge the worker immediately upon request. Do not employ that worker again on the work.

### 5-1.18 COUNTY DRUG POLICY

You, your employees, your subcontractors and their employees must comply with Alameda County's policy of maintaining a drug free work place. Under no circumstances shall anyone unlawfully manufacture, distribute, possess or use controlled substances, as defined in 21 U.S. Code Section 812, including marijuana, heroin, cocaine, and amphetamines, at any Alameda County or District facility or work site. If you or any of your employees are convicted or plead nolo contendere to a criminal drug statute violation occurring at an Alameda County/District facility or work site, provide notice within 5-days. Violation of this provision constitutes a material breach of the Contract.
