## NOTICE TO BIDDERS

On *March 12, 2024*, the Board of Supervisors of Alameda County approved this invitation for bids to provide all labor, material, equipment, mechanical workmanship, transportation, and services required for work to be performed on:

EDEN TOWNSHIP, ALAMEDA COUNTY, CALIFORNIA**

**GENERAL WORK DESCRIPTION:** The work to be done consist of providing all labor, equipment, tools, materials, workmanship, and services for traffic control; saw cutting and removing the damaged sections; placing aggregate base as cushion material; placing concrete forms; reconstructing the damaged portions of concrete or asphalt sidewalks, driveways, pedestrian ramp, curbs, gutters, median island paving and curbs; saw cutting, removing, and replacing a minimum twelve (12) inches wide section of asphalt concrete pavement adjacent to the gutter; removing existing roots; installing root control barriers; restoring any disturbed lawn and planting areas to their original condition or better; and such miscellaneous work, including removal of concrete forms, disposal off-site of all unsuitable materials, and cleanup of the site.

**ALLOTTED TIME FOR COMPLETION:** 30 working days.

**LICENSE REQUIREMENT:** The Contractor must have a Class A and/or combination of C-8 and C-12 licenses to submit a bid, as provided in Business & Professions Code section 7028.15. Licensing must be maintained throughout the contract duration.

**REGISTRATION REQUIREMENT:** To be qualified to bid or to be listed in a bid proposal, all contractors must be registered with the Department of Industrial Relations.

**BIDS DUE:** **Tuesday February 25, 2025**, 2:00 p.m., Public Works Agency, 951 Turner Court, Room 300, Hayward, CA 94545. Bids submitted after this deadline will be rejected. Submissions accepted prior will be publicly open and read immediately following the deadline. Include a bidder's security equal to at least 10 percent of the bid.
