Revitalizing the Hesperian Boulevard

Hesperian Boulevard, between A Street and Highway 880, is on the verge of a transformative makeover that will bring new vitality to the San Lorenzo commercial corridor.

HE ROADWAY WILL BE completely reconstructed and revitalized. Wider sidewalks with decorative features, pedestrian-friendly lighting and highlighted crosswalks at intersections will be installed along the length of the project. Bicyclists will enjoy new Class II (green) bike lanes in both directions. Beautiful and drought-tolerant landscaping and trees will be installed throughout the project area. An artful gateway feature will make sure everyone knows they're entering the lovely San Lorenzo business corridor. Unsightly overhead utility wires will be relocated underground. Upgraded traffic signals will help improve traffic flow and promote transit accessibility. Finally, a conduit will be installed underground, allowing for future installation of a fiber optic network.

This \$22 million project, funded in part by Measure B/BB, is currently out for bid. Construction is expected to begin this summer, and the project will take approximately three years to complete.

HEROES IN THE STORM

When rocks tumble, roads flood, trees fall and earth slides in the unincorporated areas of Alameda County, it's "GO TIME" for the PWA Maintenance and Operations Department.

The current storm season—which brought an estimated 240% of the annual rainfall between October and February—was especially brutal both for County infrastructure and the people called to fix it ... 24/7... NOW!

Whether reassigned from routine daytime activities or called out in the middle of the night, Public Works crews responded to over 260 calls for assistance between January 1 and February 21. Additionally, crews removed the equivalent of 2.5 Olympic-size swimming pools of debris from County roads.

During the height of the storm, some PWA staff worked 16-hour days, returning to the Dublin Corporation Yard to grab a quick bite and sleep a few hours on cots in the conference room before running right back out into the field.

While these storm impacts are extraordinary, they could have been much worse. By planning ahead and adequately stockpiling supplies and staging equipment in strategic County locations, emergency response times were cut dramatically, which undoubtedly reduced risk to people and property.

In addition to supporting the overall event, the Public Works Agency's Flood Control and Water Conservation District and Unincorporated Area Clean Water Programs will be co-hosting sites at Castro Valley Creek, adjacent to the Castro Valley Library trail, and at Cull Canyon Reservoir. At both of these sites, we will be doing a variety of beautification activities, including installing native trees and plants, weeding along trails, picking up litter and applying mulch.



HYDROLOGY & HYDRAULICS MANUAL UPDATED

How about the rain this winter! Our hills are green, the drought is over, and Alameda County's creeks are flowing with abundance. Throughout the season, the Alameda County Flood Control and Water Conservation District closely monitored weather forecasts and measured stream flows. This winter, little to no flooding occurred in Alameda County.

District staff want to keep it that way. The District recently released its newly updated Alameda County Hydrology & Hydraulics Manual, which includes required design criteria and hydrologic computation techniques for all new (and modifications to existing) drainage facilities that drain to Districtowned facilities in Alameda County.

The updated equations and parameters reflect the District's analysis and modeling of decades of hydrologic and meteorological data from Alameda County and surrounding areas. By following the guidelines set forth in this manual, engineers and hydrologists can more accurately predict the storm water flows and then design storm drains, channels and ponds to prevent flooding.

Did You Know ...?



... that pavement marking helps improve safety for both drivers and bicyclists?

That's right! The "sharrow" (or Shared Lane Marking)

combines a bicycle symbol and two white chevrons painted on roadways throughout the world.

Sharrow markings are designed to:

- Serve as a reminder to all roadway users that bicycles may be present in the travel lane and are allowed to use the full travel lane, when necessary;
- Provide the likely position for bike riders to position themselves in when sharing a travel lane; and
- Reduce the incidents of bicyclists weaving in and out of traffic or riding against the flow of traffic.

it's everyone's responsibility to share the road safely.
