#### 1. Call to Order

#### 4. Approval of Minutes

#### 5. Presentations

#### a) Heyer Avenue Sidewalk Improvement Project

Elizabeth Wong, Associate Engineer from the Public Works Agency shared a presentation on the Heyer Avenue Project. This is a roadway improvement project on Heyer Avenue, from Redwood Road to Center Street, in Castro Valley. She discussed the proposed improvements, presented design alternatives and sought feedback from the committee. Alternative 1 features new sidewalk, Class II bike lanes and on-street parking on both sides of the street; and Alternative 2 features new

sidewalk, buffered Class II bike lane and on-street parking on one side of the street.

Comments were received from committee members and the public.

b) Crystal Wang, AC Transit - Transit Supportive Design Guidelines Crystal Wang, as Transportation Planner from AC Transit, presented the District's plans to update their new guidelines as the Transit Supportive Design Guidelines. AC Transit's current Multimodal Design Guidelines is dated 2018. The new Transit Supportive Design Guidelines will include design that accommodates paratransit service, facilities for passenger comfort and safety at bus stops, transit operation improvements (bus/bike separation), and other design features that promote transit service. Crystal discussed the guideline elements, outreach efforts, as well as the project timeline.

Comments were received from committee members and the public.



#### East Bay Greenway Multimodal (Phase 1)

- Provide all ages and abilities, interjurisdictional active transportation facility
- On-street facility, utilize parallel streets where needed
- Avoid UPRR ROW
- Deliver within 3-5 years (funding permitting)

#### East Bay Greenway Urban Trail (Phase 2)


- Provide all ages and abilities, interjurisdictional active transportation facility
- Potential linear park enhancements
- Off-street facility in UPRR/BART corridor
- Environmentally cleared in 2018
- 10+ year timeline










#### 159th Ave to Ashland Ave
