

# **TDA Article 3**



- Annual
- Local transportation funds for all 14 cities & unincorporated areas of Alameda County to improve pedestrian and bicyclist safety
- Proposed funding allocation to be approved by the Metropolitan Transportation Commission (MTC) in Fall 2024

### Purpose

- Construction and/or engineering of a bicycle or pedestrian capital or quick build projects.
- Maintenance of a Class I shared-use path and Class IV separated bikeways.
- Bicycle and/or pedestrian safety education program (no more than 5% of county total).
- Development of a comprehensive bicycle or pedestrian facilities plans (allocations to a claimant for this purpose may not be made more than once every five years).
- Restriping Class II bicycle lanes and buffered bicycle lanes.

### **Eligible Project Types / Examples**

- Pedestrian ramp construction
- Crosswalk improvements (RRFB, HAWK, pedestrian refuge island installation)
- Shared-used path maintenance
- Class IV facility sweeper (equipment)
- Sidewalk project (repair, gap closure)
- Bicycle & pedestrian safety education programs
