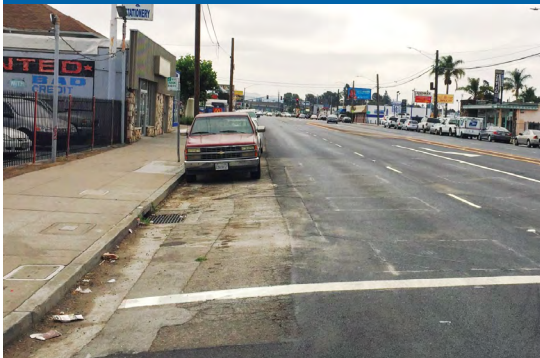

The Alameda County Public Works Agency will start Phase II of the East 14th Corridor Improvement Project in March 2020. The project is designed to improve safety and access for all users, strengthen community identity and revitalize the corridor.

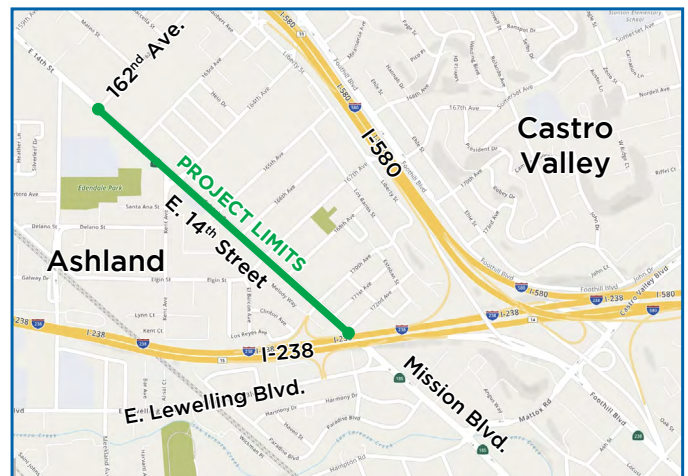
**Construction is scheduled to start in March 2020 and be completed in early 2022.** *(Schedule subject to change)*

## CORRIDOR IMPROVEMENT PROJECT FROM 162ND AVE TO THE VICINITY OF I-238

### FREQUENTLY ASKED QUESTIONS

#### **What is the E. 14th Street / Mission Boulevard Corridor Improvement Project?**

This project is a multi-year project that is occurring in three phases. Phase II will extend from 162nd Avenue to the vicinity of I-238 (through the Ashland area). Construction on this phase of the project is expected to start in March 2020.

#### **Why is this project needed?**

This is a project to beautify the Ashland business corridor and make the street safer for people walking, riding bicycles and driving through the area. East 14th Street is a very busy street that passes through residential and business communities. This project will improve sidewalks and street access, beautify the corridor provide for bike lanes and more.

#### **What will be done?**

The work includes repaving sections of the street, installing new sidewalks, high visibility crosswalks and new bike lanes. In addition, there will be raised medians with landscaping, utilities placed underground, new bus boarding islands, bike racks, as well as improved stormwater and drainage systems. When completed, the project will improve safety, provide multi-modal access, and strengthen community identity.

#### **What impacts can be expected during construction?**

Traffic will be allowed to move along E. 14th at all times. During construction, intermittent lane closures may be necessary, and traffic control/flaggers will be on site to ensure that traffic moves safely. On street parking may be restricted for short periods of time.

#### **When does construction begin and how long will it last?**

Construction is scheduled to start in March 2020. The construction is projected to take between 18 months and two years to complete.

#### **Will residents and businesses be informed before construction starts?**

Yes. Residents and business owners in the Phase II project area will be notified in advance of the construction activities.



#### **During construction, will cars be able to access businesses and homes on the corridor?**

The Alameda County Public Works Agency is committed to minimizing the construction impacts. Whenever possible, access to all businesses will remain. At times entry doors and driveways may be blocked for a short period of time. The construction project manager will notify property owners in advance if access to their properties will be impacted and seek to find a solution or another entry point in advance. Signs will be posted to guide people around construction work, and to let the public know that businesses remain open during construction.

#### **Will construction take place during holidays season? (Thanksgiving to New Year)**

Construction activities will not be conducted during the winter holiday season.

#### **What are the construction hours?**

The general work hours will be from 8:00 a.m. to 5:00 p.m. Whenever possible, construction activities will be scheduled to lessen impacts to commercial areas. In the vicinity of schools, construction hours will be modified to avoid conflict with school activities.
